JOB DESCRIPTION

JOB TITLE: Seasonal Spray Operator

POSITION ESTIMATED START DATE: Seasonal, May through August

Starting Wage: \$15.00 per hour with potential for a raise

JOB SUMMARY: Goshen County Weed and Pest Control District (GCWP) is seeking full-time employees for the position of Seasonal Spray Operator. This will be an at-will, seasonal position from May to August.

DUTIES AND RESPONSIBILITIES:

- Spraying Operations: Complete weed and pest treatments as directed in a safe and professional manner consistent with all application laws.
- Equipment Management: Use and maintenance of all spray equipment, including trucks, ATV's, UTV's and backpack sprayers.
- Facilities Management: Maintain clean and safe working conditions on all job sites.

KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of weed and pest management principles and practices
- Skill in utilizing problem solving strategies
- Knowledge and ability to apply technical and mechanical skills
- Knowledge of current technological applications such as GPS and basic computer skills
- Ability to establish and maintain effective working relationships with other employees, supervisors, Board members, and the general public

EQUIPMENT USED:

- Automobile, ATV, UTV, various spray equipment, GPS, telephone, calculator, computer, and similar equipment.

ENVIRONMENTAL CONDITIONS:

- The position duties are performed in indoor and outdoor environments
- May be exposed to adverse conditions while driving to various locations as well as during any service-related activities
- Potential exposure to pesticides, fumes, toxins, odors, dust, and mists
- Moderate seasonal exposure to extreme heat or temperature changes

PHYSICAL REQUIREMENTS:

- Ability to conduct activities involving extensive walking over rugged terrain or standing with a backpack weighing up to 50 lbs.
- Ability to lift burdens weighing up to 80 lbs. and carry, push and/or pull burdens weighing up to 300 lbs. on a limited to moderate basis
- Ability to grasp and manipulate tools, equipment, and materials used in the maintenance of facilities and equipment
- Ability to conduct activities involving climbing, balancing, stooping, kneeling/bending, crouching, crawling, twisting, and reaching

- Ability to operate a manual and automatic transmission motor vehicle, all-terrain vehicle, and utility terrain vehicle

OTHER REQUIREMENTS:

- Must have a valid driver's license and be 18 years old at time of employment
- Ability to understand and follow-through from verbal and written information and instruction
- Ability to use mathematical reasoning when necessary to carry out the management and operational duties of the department
